#### 2. DECLARATIONS OF INTEREST - None.

#### 3. MINUTES -

 i) The Minutes of the Annual Parish Council Meeting held 21<sup>st</sup> June, 2019 had been previously circulated to all Members.

#### 4. PUBLIC FORUM FOR QUESTIONS -

A resident raised concern about boundary hedgerows causing obstruction when turning into Birtles Lane from Macclesfield Road (when travelling from Alderley Edge). The Clerk reported that Cheshire East Highways has inspected the hedge and concluded that the hedge is not encroaching into the highway. It is, also, not considered to present an obstruction to visibility for highway users. The road is inspected three times annually, therefore, any future issues can be identified through this process.

A resident raised a query about development at Lower Yew Tree Farm relating to the requirements within the planning permission for the hedge bank to be re-aligned and a replacement hedge to be planted. Members advised that this query would be referred to Cheshire East Council.

A resident raised concern about vehicles parking along Birtles Lane near to Varden Town Cottages. Members noted that the majority of these vehicles appeared to be associated with the properties opposite, therefore, it may be difficult to address this issue in a manner which is satisfactory to both highway users and local residents.

A resident raised concern that the septic tank provision for Varden Town Cottages did not appear to be sufficient for the present usage which was causing effluent to flood onto adjacent land. Members suggested that the matter be referred to the Environment Agency.

A resident raised concern about the lack of useable footway along School Lane near to Brook Cottage. It was reported that there used to be a footway, however, this has become overgrown. This is a popular route for pedestrians walking from Hare Hill to Alderley Edge. Members advised that this query would be referred to Cheshire East Council.

- DECISION a) That the Clerk submit a query to Cheshire East Council regarding the boundary treatments at Lower Yew Tree Farm, Birtles Lane.
  - b) That the Clerk submit a query to the Environment Agency regarding the septic tank at Varden Town Cottages following receipt of photographs from the resident.
  - c) That the Clerk submit a report to Cheshire East Highways regarding the footway along School Lane.

#### 8. PLANNING APPLICATIONS -

 i) To receive the latest planning schedule and discuss new applications. (Appendix C) Members noted that no planning decisions had been issued by Cheshire East Council in respect of development within the Parish since the last meeting.

**19/3217M** - Members raised concerns about the proposed development and assertions within the application. **19/3292M** - Members did not raise any comments in respect of this application.

37/19 RESOLVED a) That the following objection be submitted in respect of planning application 19/3217M:

1. The site of the proposed dwelling lies within the Green Belt and it is not considered that any very special circumstances have been demonstrated to justify such development nor is Over Alderley defined as an infill village in the Draft Site Allocations and Development Policies Document.

2. It is considered that the proposed development does not constitute 'infill development' as the site does not form part of an otherwise built up frontage nor is Over Alderley defined as an infill village in the Draft Site Allocations and Development Policies Document.

3. The proposed development, accommodated by the division of an existing curtilage, is considered to be over intensification of a rural plot and to detrimentally affect the openness of the countryside in this rural location.

4. Over Alderley is a very popular location for walkers due to the National Trust land at Hare Hill and Alderley Edge. Over Alderley FP7 passes directly adjacent to Adders Wood, therefore, the proposed development will detrimentally affect the enjoyment of walkers in this popular, rural location by introducing urbanising features into an otherwise rural setting.

5. Members note the recent removal of the agricultural clause on the property known as Adders Wood (planning application 18/1646M). The planning officer for this application described the site and context in the Officer's Report as, "Adders Wood is a detached dwellinghouse in a relatively isolated location in the Green Belt, off Prestbury Road in Over Alderley". This supports the views of the Parish Council in points (1), (2) and (3) above.

6. It is noted that planning application 19/3045M, also associated with Adders Wood, has been recently approved. It is considered that when taking into consideration this approved 8m extension, together with the additional proposed dwelling, there will be further exacerbation of the urbanisation of this rural location which will be detrimental to the local area.

b) That 'no objections' be submitted in respect of planning application 19/3292M.

Proposed Councillor I. Beaumont Seconded: Councillor J. Wilson All in favour HIGHWAY MAINTENANCE & ENHANCEMENTS -

#### i) Update on outstanding highway matters -

Signage repairs had not yet been completed.

- Flood on Prestbury Road, near to Hare Hill, has been inspected, however, further work is required due to a blockage within the system. A date for this further work is not presently available.
- ii) To receive highway matters for attention from Members -
  - Footway condition near to Brook Cottage, School Lane.

#### DECISION a) That the Clerk report the above highway defect to Cheshire East Council.

iii) Macclesfield Road (B5087) Speed Review - The Clerk reported that she was awaiting a response from the officer who is dealing with this review.

Members discussed the speed limits on Macclesfield Road and Birtles Lane. It was considered that these should be reduced to encourage drivers to travel more slowly through the Parish. Borough Councillor P. Findlow advised that it was unlikely that the speed limit on Birtles Lane would be reduced as it did not meet the criteria presently used to determine speed limit areas.

# DECISION a) That the Clerk obtain the criteria for the implementation of speed limits on rural roads.

#### b) That the Clerk circulate the speed review report to Members.

#### 10. COMMUNITY -

- i) **Over Alderley Primary School Charity -** Borough Councillor P. Findlow reported that this matter is still being pursued by the Cheshire East Legal Team.
- ii) Update on Superfast Broadband Provision within Parish There was nothing to report.
- iii) Ashbrook Road Allotments There was nothing to report.
- iv) **Red Telephone Kiosk within Parish -** Councillor D. Burns confirmed that the Over Alderley & Birtles Reading Room do not wish for the kiosk to be relocated to their site. The Clerk reported that she had not yet concluded the investigation into possible options available to dispose of the telephone kiosk.
- v) Alderley Park Liaison Committee Councillor I. Beaumont reported that he was unable to attend the last meeting, however, the key issue affecting the Parish is the timetable for the release of the s106 funds. This is being pursued by the relevant parties to allow work at the Over Alderley & Birtles Reading Rooms to commence as soon as possible. Councillor J. Wilson enquired about the footpath and bridleway provision within the Alderley Park site. It was reported that there will be footpaths and bridleways available for public use as the development progresses.
- vi) **Parish Council Notice Boards** The Clerk reported that two of the Parish Council notice boards are deteriorating in condition and require replacing.
